- Improperly packaged returned merchandise.
- Any items which may have been modified or are missing parts.
- Merchandise returned after ten (10) days of RGA approval.
- · Used merchandise with no resale value.
- · Merchandise that is discontinued or obsolete.
- Product returned does not match the conditions for return stated during the initial RGA request.
